Terms: All orders will be shipped COD unless terms have been arranged in advance by the credit department. Standard Terms are net 10 prox. Special orders will require a deposit and cannot be cancelled or returned. A fee of \$30.00 will be charged on any checks that have been returned unpaid by the bank.

Returns: All returns must be made within 30 days of the purchase. Merchandise being returned must be in the original packaging. Returns must also be accompanied by the original invoice and authorized by LARS LLC d.b.a Hardware Imagination-Tech. All terms will be subjected to a 20% restocking charge.
